OIL PIPELINE TARIFF FILING

Re: Pelican Gathering Systems, LLC—Tariff Filing

Dear Secretary Bose:

In compliance with the Interstate Commerce Act, 49 U.S.C. § 1 *et seq.*, and the Rules and Regulations of the Federal Energy Regulatory Commission (“Commission”), 18 C.F.R. Part 341, Pelican Gathering Systems, LLC (“Pelican”) hereby submits for filing FERC No. 2.19.0 to become effective July 1, 2022.

I. Explanation of Tariff Filing

Pelican is filing FERC No. 2.19.0 in compliance with 18 C.F.R. § 342.3 (Indexing) to increase the rates for services outlined in the tariff, with such increases to become effective July 1, 2022. Pursuant to 18 C.F.R. § 342.3, Pelican is enclosing an Index Summary that outlines, with respect to the rates in FERC No. 2.19.0, the following information: (1) the current index ceilings for the period July 1, 2021 through June 30, 2022, (2) the current rates, (3) the index ceilings that will become effective on July 1, 2022, and (4) the rates that will become effective on July 1, 2022.

Pelican has also revised the cover page of the tariff to (1) reference the regulation pursuant to which the tariff is being filed and (2) remove language requesting special permission to file the tariff on short notice, as such language is not applicable to this filing.
