Dear Secretary Bose:

In compliance with the Interstate Commerce Act, 49 U.S.C. § 1 *et seq.*, and the Rules and Regulations of the Federal Energy Regulatory Commission ("Commission"), 18 C.F.R. Part 341, Pelican Gathering Systems, LLC ("Pelican") hereby submits for filing FERC No. 2.11.0 to become effective July 1, 2019.

I. Explanation of Tariff Filing

Pelican is filing FERC No. 2.11.0 to cancel certain transportation movements currently set forth in the tariff. In particular, Pelican is cancelling all transportation movements from Plains Van Hook Terminal in New Town, Mountrail County ("Plains Van Hook"), and all transportation movements to Plains Van Hook. Pelican is also cancelling Note 1 of the tariff indicating that transportation service from Plains Van Hook will automatically be cancelled as of December 31, 2018, as this note is no longer applicable given the cancellations noted above. Pelican is cancelling this service because Plains Van Hook is no longer a point at which Pelican can receive product into its system or deliver product from its system. All shippers that previously utilized the above-noted services that are being cancelled in FERC No. 2.11.0 have been on notice that such transportation services will no longer be provided by Pelican.

In addition, Pelican has revised the cover page of the tariff to (1) reference the regulations pursuant to which the tariff is being filed, and (2) update the issuer information so that the Commission and shippers have the most up-to-date information concerning the person responsible for issuing the tariff. Apart from these changes, Pelican has not made any other changes to the tariff, including to the rates, rules and regulations.
