In compliance with the Interstate Commerce Act, 49 U.S.C. § 1 *et seq.*, and the Rules and Regulations of the Federal Energy Regulatory Commission ("Commission"), 18 C.F.R. Part 341, Pelican Gathering Systems, LLC ("Pelican") hereby submits for filing FERC No. 2.17.0 to become effective March 1, 2022.

I. Explanation of Tariff Filing

On December 17, 2020, the Commission issued an order establishing an oil pipeline index of Producer Price Index for Finished Goods ("PPI-FG") plus 0.78% for the five-year period beginning July 1, 2021. On January 20, 2022, the Commission issued an order granting in part, and denying in part, rehearing of its December 2020 Order and established therein an oil pipeline index of PPI-FG minus 0.21% for the five-year period beginning July 1, 2022 ("Revised Index"). That same day, the Commission issued a Notice of Change in Oil Pipeline Index Figure setting forth an index multiplier of 0.984288 ("March 2022 Index") pursuant to the Revised Index. In the January 2022 Order, oil pipelines were directed to recompute their index ceiling levels to reflect application of March 2022 Index and to lower any transportation rates, effective March 1, 2022, that exceeded the recomputed ceiling levels. Pelican is submitting FERC No. 2.17.0 to decrease certain of the transportation rates contained therein to reflect application of the March 2022 Index. Pelican is enclosing herewith an Index Summary that outlines the following information: (1) the pre-July 1, 2021 index ceiling levels, (2) the current rates, (3) the index ceiling levels that will become effective on March 1, 2022, and (4) the rates that will become effective or remain effective on March 1, 2022.

In addition, Pelican has (1) included new language on the cover page of the tariff notifying shippers that, to the extent all or any portion of the Commission's January 2022 Order is reversed on rehearing or appeal and the index for the five-year period commencing July 1, 2021 is increased

above the Revised Index, Pelican reserves the right to collect from shippers the positive difference, if any, between the rates resulting from application of the Revised Index and the rates resulting from application of the new index for all barrels shipped from March 1, 2022 forward, and (2) revised language on the cover page of the tariff to reference the regulation pursuant to which the tariff is being filed.
