OIL PIPELINE TARIFF FILING

Re: Pelican Gathering Systems, LLC—Tariff Filing

Dear Secretary Bose:

In compliance with the Interstate Commerce Act, 49 U.S.C. § 1 *et seq.*, and the Rules and Regulations of the Federal Energy Regulatory Commission (“Commission”), 18 C.F.R. Part 341, Pelican Gathering Systems, LLC (“Pelican”) hereby submits for filing F.E.R.C. No. 2.16.0 to become effective October 1, 2021.

I. Explanation of Tariff Filing

Pursuant to 18 C.F.R. § 342.4(c) (Settlement Rates), Pelican is filing F.E.R.C. No. 2.16.0 to increase the pumpover charge set forth in the tariff that applies to movements of crude petroleum moved through the connection at Sacagawea Pipeline, New Town, Mountrail County, North Dakota. Pelican notes that, all shippers who, on the date of this filing, are using the service to which the pumpover charge is applied have agreed in writing to the increased charge set forth in F.E.R.C. No. 2.16.0. In accordance with 18 C.F.R. § 342.4(c), Pelican is filing herewith a sworn affidavit confirming this fact.

In addition, Pelican has revised language on the cover page of the tariff to indicate the regulation pursuant to which the tariff is being filed.

Rates from any origin not specified above to any of the destinations listed above or any origin point to a destination point not specified above shall be charged a rate in accordance with the provisions of 18 C.F.R. § 341.10. Pursuant to 18 CFR 341.10(a)(2) Carrier will file a tariff publication applicable to these transportation movements if the intermediate point is to be used on a continuous basis for more than 30 days.
