In compliance with the Interstate Commerce Act, 49 U.S.C. § 1 *et seq.*, and the Rules and Regulations of the Federal Energy Regulatory Commission ("Commission"), 18 C.F.R. Part 341, Pelican Gathering Systems, LLC ("Pelican") hereby submits for filing F.E.R.C. No. 2.10.0 to become effective July 1, 2018.

## I. Explanation of Tariff Filing

Pelican is filing F.E.R.C. No. 2.10.0 in compliance with 18 C.F.R. § 342.3 (Indexing) to increase the rates for services outlined in the tariff, with such increases to become effective July 1, 2018. Pursuant to 18 C.F.R. § 342.3, Pelican is enclosing an Index Summary that outlines, with respect to the rates in F.E.R.C. No. 2.10.0, the following information: (1) the index ceilings for the period July 1, 2017 through June 30, 2018, (2) the current rates, (3) the index ceilings that will become effective on July 1, 2018, and (4) the rates that will become effective on July 1, 2018.

In addition, Pelican is making the following changes to the tariff: (1) revised language on the cover page of the tariff to indicate that the tariff is being filed in compliance with 18 C.F.R. § 342.3, and (2) cancelled language on the cover page of the tariff seeking special permission to file the tariff on short notice pursuant to 18 C.F.R. § 341.14 because that provision is not applicable to this tariff filing. Apart from the changes noted above, Pelican has not made any other changes to the tariff.
