OIL PIPELINE TARIFF FILING

Re: Pelican Gathering Systems, LLC—Tariff Filing

Dear Secretary Bose:

In compliance with the Interstate Commerce Act, 49 U.S.C. § 1 *et seq.*, and the Rules and Regulations of the Federal Energy Regulatory Commission ("Commission"), 18 C.F.R. Part 341, Pelican Gathering Systems, LLC ("Pelican") hereby submits for filing FERC No. 2.15.0 to become effective July 1, 2021.

I. Explanation of Tariff Filing

Pelican is filing FERC No. 2.15.0 pursuant to 18 C.F.R. § 342.3 (Indexing). On May 14, 2021, the Commission issued its Notice of Annual Change in the Producer Price Index for Finished Goods, 175 FERC ¶ 61,117 (2021), as modified pursuant to the Errata Notice issued on May 17, 2021 (collectively, the "Notice"), which established the index adjustment applicable to the period July 1, 2021 to June 30, 2022. Pursuant to the Notice, the index adjustment applicable to this period is a negative 0.005812 ("2021 Index"). Accordingly, Pelican is lowering its rates set forth in the tariff to reflect application of the 2021 Index.

Pelican is enclosing herewith an Index Summary that outlines, with respect to the rates in F.E.R.C. No. 2.15.0, the following information: (1) the current index ceiling levels, (2) the current rates, (3) the index ceiling levels that will become effective on July 1, 2021, and (4) the rates that will become effective on July 1, 2021.
