Re: Pelican Gathering Systems, LLC—Tariff Filing

Dear Acting Secretary Reese:

In compliance with the Interstate Commerce Act, 49 U.S.C. § 1 *et seq.* ("ICA"), and the Rules and Regulations of the Federal Energy Regulatory Commission ("Commission"), 18 C.F.R. Part 341, Pelican Gathering Systems, LLC ("Pelican") hereby submits for filing F.E.R.C. No. 2.23.0 ("Index Tariff") to be effective October 1, 2024, which is on less than one day's notice.

I. Explanation of Tariff Filing

Pelican is filing the Index Tariff in compliance with 18 C.F.R. § 342.3 (Indexing) and the Commission's *Order Reinstating Index Level*, 188 FERC ¶ 61,173 (2024) to increase the rates and fees for services outlined in the Index Tariff, with such increase to become effective October 1, 2024. Pursuant to 18 C.F.R. § 342.3, page 1 of the attached Exhibit A includes an index summary that outlines, with respect to the rates and fees in the Index Tariff, the following information: (1) the current rates and fees, (2) the revised index ceiling levels that became effective on July 1, 2024, and (3) the rates and fees that will become effective on October 1, 2024.

In accordance with footnote 8 of the *Order Reinstating Index Level*, the docket establishing Pelican's starting ceiling rates (*i.e.*, the ceiling rates that became effective or were otherwise in effect on June 30, 2021), along with the calculation of the recomputed ceiling levels effective as of July 1, 2022, July 1, 2023, and July 1, 2024, are included on page 2 of the attached Exhibit A.

II. Request for Short Notice

Pursuant to 18 C.F.R. § 341.14 (Special Permission), Pelican requests that it be granted a waiver under Section 6(3) of the ICA to file the Index Tariff on less than one day's notice, so that it may become effective on October 1, 2024. Pelican submits that good cause exists for granting a waiver because doing so will allow Pelican to implement the revised index ceiling levels and rates, which have been calculated in accordance with the Commission's *Order Reinstating Index Level*, as soon

as possible. Pelican acknowledges that this tariff publication is conditionally accepted subject to refund, pending a thirty-day review period.

III. Certification
